#### 1. ROLE SUMMARY

Autoridade Nacional do Petroléo e Minerais (ANPM) is a Timor – Leste's body responsible of managing and regulating petroleum activities in the Timor-Leste's exclusive jurisdictional areas and in the JPDA in accordance with the Decree Law on the establishment of the ANPM, the Timor-Leste Petroleum Activities Law, and the Timor Sea Treaty. The ANPM also tasked to regulate mineral operations activities in the territory of Timor-Leste in accordance with the applicable legal frameworks. Under the Timor Sea Treaty, the ANPM is mandated by Timor-Leste and Australia as the Designated Authority (DA) to administer and regulate the upstream petroleum activities within the Joint Petroleum Development Area (JPDA) in the Timor Sea.

## 2. KEY OBJECTIVES

- 2.1 To direct and coordinate oil and gas development and production activities in the Timor-Leste exclusive jurisdiction areas and within the ANPM jurisdiction consistent with Timor-Leste Petroleum Activities Law and with the Timor Sea Treaty arrangements between Timor-Leste and Australia;
- 2.2 Report to the president of ANPM and provide development and production advices as required;
- 2.3 Manage and supervise the functions and staff of the Development and Production Directorate;
- 2.4 Manage and supervise Development and Production Directorate staff, with emphasis on Goals, Teamwork, Motivation, Establish system, and Effective Prioritisation.

## 3. PRINCIPAL ACCOUNTABILITIES

- 3.1. Ensure the achievement of annual objectives for the Development and Production Team, and the ANPM;
- 3.2. Approve Contract Operator's development and production activities;
- 3.3. Monitor the performance of development and production activities conducted in the Timor-Leste Jurisdiction and within the JPDA the jurisdiction;
- 3.4 Ensure effective communication and cooperation between Directorates;
- 3.5 Monitor Industry Legislation to ensure the effective maintenance of the ANPM's own Regulations, Directions and Guidelines;
- 3.6 Monitor activities to ensure compliance with internal standards via the Management System, and participate with other Directors, in the overall administration of the ANPM;
- 3.7 Prepare/ approve / accept development and production reports;
- 3.8 Supervise all activities associated with Contract Awards, Annual Work Programs and Budgets, Development Plans, Production Facilities, Contract Variations/Terminations.
- 3.9 Empowering Timor-Leste nationals through training program;
- 3.10 Attend/ report at Management Committee Meetings, Board of Director Meetings, and Joint Commission Meetings, when required;
- 3.11 Establish effective working relationships with relevant Timor-Leste's and Australian authorities;



3.12 Any other duties related as directed by the President.
