### Announcement of Public Consultation

#### **Marine Seismic Survey (PSC TL-SO 22-23)**

1. Authorised Person: **Eni Timor 22-23 B. V.**
2. Location of the proposed project: Marine seismic survey area located in the Timor Sea approximately 175km from the southeast coast of Timor-Leste and circa 300km southeast of Dili, Timor-Leste.
3. **Eni Timor 22-23 B. V.** is planning to conduct a marine seismic survey as part of the initial exploration work commitment for Eni operated PSC TL-SO 22-23. The survey covers an area of approximately 1,500km<sup>2</sup> (50km x 30km) and is located on the Sahul Shelf in water depths ranging from 40 to 180m. **Eni Timor B. V.** proposes to acquire seismic data within the survey area over a period of approximately ten weeks, using towed streamer operations commencing between July and September 2025. Seismic data acquisition will occur with 24-hour operations, although temporary shutdown periods may be required in the event of poor weather or other adverse conditions. The seismic survey will be conducted utilising a specialised vessel which tows an array of receivers (hydrophones attached to streamers) and pneumatic sources below the water surface and generate sound waves using pulses of compressed air. The sound waves, reflected from horizons at and below the seafloor, will be detected and recorded by the receivers, towed by the same vessel to gain images of the subsurface for the purpose of hydrocarbon exploration. The data acquired from the survey will then be processed to produce 3D seismic images which are interpreted to create geological maps and identify any geological features which could be traps for hydrocarbons. The data will help identify the best location for drilling a well. To support the main seismic vessel, there will be a support vessel and three chase vessels to protect the tow vessel and towed equipment from other vessel traffic, and to protect other users of the sea from entanglement or other damage from collisions with towed seismic source.
4. In accordance with Decree-Law No. 39/2022 of 8<sup>th</sup> June, 1<sup>st</sup> amendment to Decree-Law No. 5/2011 of 9<sup>th</sup> February on Environmental Licensing and Decree-Law No. 32/2016 of 17<sup>th</sup> August on Offshore Petroleum Operations, the proposed project is classified as a **Category B** project and shall subject to initial environment examination process as specified in the referred Decree-Laws.
5. **Eni Timor 22-23 B. V.** shall carry out public consultation on the draft Simplified Environmental Impact Statement (SEIS) and Environmental Management Plan (EMP) prior to submitting the referred documents to the *Autoridade Nacional do Petróleo* (ANP), which acts as the Environmental Authority for the oil and gas sector.
6. The draft Simplified Environmental Impact Statement and Environmental Management Plan are available for public consultation.



1. Proponente: **Eni Timor 22-23 B. V.**
2. Lokalizasaun ba projetu ne'ebé propoin: Levantamentu Sízmiku Mariña lokaliza iha Tasi Timor, kuaze 175km husi kosta sudeste Timor-Leste no maizoumenus 300km sudeste husi Dili, Timor-Leste.
3. **Eni Timor 22-23 B. V.** hanesan operador ba Kontratu Fahe Produsaun (PSC) TL-SO 22-23 iha planu atu halo levantamentu sízmiku mariña, hanesan komitmentu iha faze initial atividade esplorasaun nian iha bloku refere. Fonte de onda sira ne'e sei kria onda sonora (sound waves) ne'ebé sei pasa liu husi bee hafoin refleta husi tasi okos no kamada fatuk sira iha rai okos (subsurface rock layers) no sei rekorda husi hidrofone sira ne'ebé aneksa iha kabu reseptor sira (streamers).
