

# **EXPRESSION OF INTEREST (EOI) FOR INTEGRATED SURF MANAGEMENT SERVICES**

### BACKGROUND

Finder Timor-Leste B.V. (Finder) is an oil and gas company with an office located in Dili with its parent Company, Finder Operations Pty Ltd, located in Perth, Australia. Finder is the Operator of PSC-TL-SO 19-11 (PSC 19-11), effective from August 2024.

Recognising the requirements, Finder is seeking expressions of interest for reputable, capable and experienced service providers for the provision of the Development Subsea, Umbilical, Riser and Flowline (SURF) and other support services as detailed below.

This EOI does not constitute a commitment, implied or otherwise, that Finder will proceed to further contracting any of the scope of work/services outlined below.

#### **Field and Location Overview**

The proposed development lies within the previously appraised Kuda Tasi and Jahal fields within PSC 1911.




Figure 1: Location of Kuda Tasi and Jahal Oil Fields

The location of PSC 19-11 and fields can be seen in Figure 1. The Kuda Tasi and Jahal oil fields fall under the jurisdiction of the Timor-Leste authorities and can be found in the north of PSC 19-11. Water depths range from 400-430m. The development project is expected to be a 3 well standalone development with the potential for future additional wells.

# SCOPE OF SERVICES

For each of the work scopes listed, as a minimum, subsea contractors shall have the capacity and experience to provide the following integrated services and equipment requirements:

- 1. SURF Engineering to facilitate the complete EPCIC work scope and execute the project planning for the Kuda Tasi and Jahal development in PSC 19-11 for earliest execution in mid-2026.
- 2. Provision of all Long Lead Subsea equipment as required.
- 3. Services (General)
  - Project Management and Engineering Management of Subsea scope of work required in water depths up to ~450m within the Kuda Tasi and Jahal fields
  - Offshore supply of installation vessels (Mob / Demob)
  - Supply Base Services
  - Helicopter Services
  - Regulatory Approvals (HSEQ Documents and suitable Safety Case requirements)
  - Customs and Immigration Services
  - Fuel Delivery Services
  - Communications
  - Positioning Services
  - Travel and Logistics Services
  - Import & Export Services
  - Weather reporting Services
  - Emergency Response Services
