Timor-Leste Australia Energy Partnership

### Overview

The Timor-Leste Australia Energy partnership (TLAEP) is led by Australia's Department of Industry, Science and Resources (DISR) and Timor-Leste's Autoridade Nacional do Petróleo (ANP). The Partnership is jointly administered by the Energy Partnership Secretariat, consisting of representatives from DISR, ANP and the Department of Foreign Affairs and Trade (DFAT).

The Timor-Leste Australia Energy Partnership aims to share expertise, build industry connections, deepen bilateral trade and investment links and build workforce capability in Timor-Leste's resources sector. The partnership supports business, university, training providers, and government delegate visits between Timor-Leste and Australia and builds on existing industry and government collaboration.

## Invitation for Expression of Interest

As part of this initiative, the Energy Partnership Secretariat invites expressions of interest (EOI) from Timorese companies and Training Providers to participate in the NT Resources Week Conference in Darwin, Australia scheduled for September 2025. Six (6) representatives from selected companies will be fully funded for travel, accommodation, visas, meals and SEAAOC conference registration.

The Energy Partnership Secretariat will identify competent Timorese suppliers/subcontractors with the capability of being awarded tenders for LNG operations, supplies, CCS and decommissioning activities.

# **Eligibility Criteria**

To be considered for participation, companies must meet the following requirements:





**Company/Training Providers Registration**: Must be a registered Timorese-owned and operated organisation/company actively working in the energy sector.

**Tender Interest**: Must demonstrate a clear interest in applying for oil and gas tenders within Timor-Leste.

**Project Awareness**: Have a solid understanding of current and upcoming oil and gas projects in Timor-Leste.

Language Proficiency: Must have the ability to communicate effectively in English.

**Networking Capability**: Must be confident in networking and utilizing the booth provided by the Energy Partnership.

**Travel Documentation**: Must hold a valid passport with at least six months' validity from the date of entry into Australia and have the capability to obtain a business visa.

**Availability**: Must be available to participate for the entire duration of the scheduled activity week.

### The Energy Partnership will cover the costs of the following items:

The Energy Partnership will cover the following costs for selected participants:

**Travel and Accommodation:** All international and domestic flights, ground transportation, and required accommodation for the duration of the program will be fully covered.

**Meals:** Breakfast, lunch, and dinner will be provided daily while participants are in Australia.

**Visa Costs:** The Energy Partnership will cover the cost of an Australian business visa appropriate for the trip.

**Conference Registration:** The Energy Partnership will cover the cost of registration for the Southeast Asia Australia Offshore and Onshore Conference (SEAAOC) for one participant per company or training provider.

- 1. **Company/Training Providers Overview**: Briefly describe your organisation/company, including its operations and areas of expertise.
- 2. **Supply of Goods and Services or Trainings**: Does your organisation/company currently operate or provide goods or services, or provides trainings on fields related to oil and gas in Timor-Leste?





- 3. Does your organisation/company planned or intend to be involved (directly or indirectly) in the Carbon Capture and Storage (CCS) field?
- 4. **Trip Objectives**: How would your company benefit from participating in the trip to Australia?
- 5. **Tender Interest**: Does your company have an interest in applying for the supply of goods and services related to oil and gas tenders in Timor-Leste?
- 6. **Nominated Representative**: Provide the full name, position, and contact details of the individual nominated to represent your company.
- 7. **English Proficiency**: What is the nominated individual's level of English proficiency?
- 8. **Passport Validity**: Does the nominated individual hold a valid passport suitable for travel to Australia (i.e., with at least six months' validity)?
