These companies will exhibit from the Timor-Leste Pavilion, with all travel, accommodation, visa arrangements, and meals fully funded by the Partnership.

As part of this initiative, the Energy Partnership will spotlight qualified Timorese suppliers and subcontractors with the expertise to compete for tenders in LNG operations, supply chains, and decommissioning projects—helping position Timor-Leste as a trusted partner in the global energy sector.

Companies selected will exhibit at the Timor-Leste Pavilion, with the following costs fully covered by the Partnership:

- Travel & Accommodation: All flights, domestic transport, and required accommodation.
- Meals: Breakfast, lunch, and dinner during the program.
- Australia Visa Arrangements: Support of an Australian business visa.



Selection Criteria:

To be eligible, your company must:

- Be registered, Timorese-owned and operated within the energy sector
- Demonstrate an interest in participating in Oil and Gas tenders in Timor-Leste
- Have a comprehensive understanding of ongoing and upcoming Oil and Gas projects in Timor-Leste.

Ensure the nominated representative:

- Has English communication skills
- Is confident in networking and maximizing booth opportunities
- Holds a valid passport (6+ months validity) and can obtain a business visa
- Is available for the entire week in Australia

Submission Requirements: Deadline 26 January

Please submit a single document (maximum 800 words) that includes:

1. A brief background on your company
2. How your company will benefit from attending EXA 2026
 - Details of the nominated representative
 - Confirmation that the individual can speak and understand English
3. Confirmation that the representative has a valid passport and can obtain an Australian visa
4. Confirmation that your company has promotional materials available for display at the pavilion
